APPLYING TO THE FINANCE SUMMER SCHOOL

The Finance Summer School at Université Paris Dauphine - PSL, London campus is academically competitive and rigorous. Places are limited and so we ask prospective students to submit an application for the programme. We also recognise that this is good practice for applicants future job applications and interviews in anglophone environments.

To submit your application, please complete the form available on our website at london.dauphine.psl.eu/programmes-and-training/summer-schools/admissions.

You will need to provide:

- An up-to-date Curriculum Vitae (CV).
- Your 2022-23 grades transcript (for students only)
- English level B2 minimum (from an approved IELTS, Cambridge or TOEFL test)
- An application fee* of £50 (if you are not successful in this application, we will return your application fee)

If you fail to provide an English test, you will be invited to a Teams interview to prove your level of English.

As spaces are limited, we strongly recommend applying as early as possible.

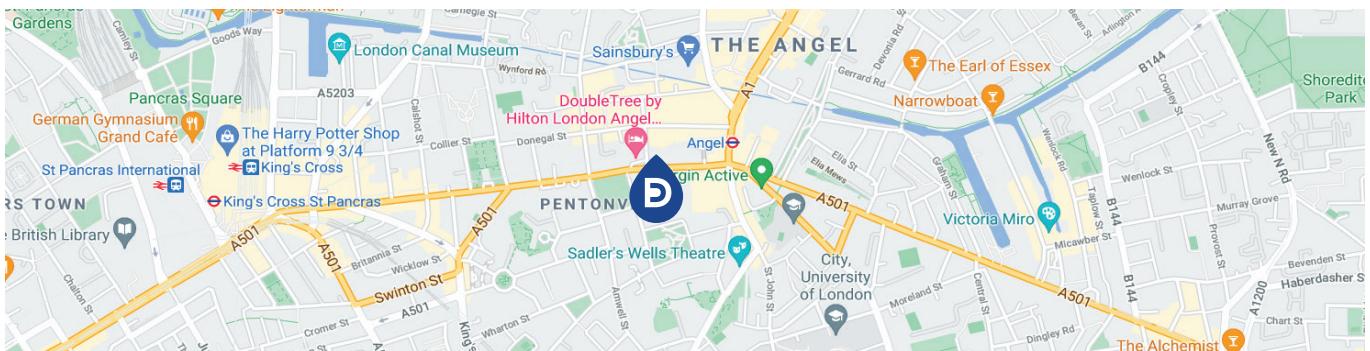
